Subsequent discussions, agreements and understandings, whether verbal or in writing, are subsumed by the Agreement. Any changes required will be in the form of written agreement between both the Institutions and the units involved.
- This Agreement is not considered to be a contract creating legal and financial obligations between Lady Brabourne College and Basanti Devi College. This Agreement is designed to facilitate and develop genuine and mutually beneficial study programmes, research collaborations and student exchange programmes.
- 3. It is agreed that the PG departments of English, Lady Brabourne College and Basanti Devi College will work together to promote the following:
 - a) Student Seminars on an Exchange Basis between the two Institutions.
 - b) Lecture Series involving Teacher Exchange between the Two Institutions
 - c) Facilitating Publications of selected Papers Presented.

- 4. This Agreement, when executed by the concerned parties, shall continue for a period of three (3) years from the day of signing it. Upon written agreement by all concerned parties of both the Institutions this Agreement may be renewed further for duration to be mutually decided. Either party may terminate the Agreement with six (6) months written notice of intent to terminate the same.
- Financial resource mobilization for implementation of the initiatives will be discussed and concerned parties may reach out to third party funding for the same on the basis of mutual consent of all concerned parties.
- 6. This Agreement shall not be construed to create a relationship of partners, brokers, employees, servants, joint ventures or agents a between the parties. The parties to this Agreement are acting as independent participants. In the event that the parties decide to engage in activities which involve employment, separate agreement addressing those issues will be required.
- The concerned parties shall cooperate to resolve any dispute or misunderstanding by collaboration and discussion.


